Subject:- Recognition certificate for the school under sub-rule (4) of rule 15 of Right of Children to Free and Compulsory Education Rules, 2010 for the purpose of section 18 of Children to Free and Compulsory Education Act, 2009.

Sir,

With reference to your Form I dated 24.07.2013 and subsequent inspection in this regard,

I convey the grant for provisional recognition to the Alok Public School up to class Xth.

The above sanction is subject to fulfilment of following condition:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class – IXth & Xth
2. The school shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure – I) and the Right of Children to Free and Compulsory Education Rules, 2000 (Annexure-II).
3. The school shall admit in class I (or in pre-school class, as the case may be) to the extent of 25 % of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion.
4. The Society/school shall not collect any capitation fee and subject thee child or his or her parent or guardian to any screening procedure.
5. The school shall not deny admission to any child for lack of age proof shall adhere to the provision of section 15 of the Act. The school shall ensure:-
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - (ii) No child shall be subjected to physical punishment or mental harassment.
 - (iii) No child is required to pass any board examination till the completion of elementary education.
 - (iv) Every child completing elementary education shall be awarded a certificate as laid down under rule-25.
 - (v) Inclusion of student with disabilities/special needs as per provision of the Act.
 - (vi) The teachers are recruited with minimum qualifications as laid under section 23 (i) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications with in a period of 5 years.
 - (vii) The teacher performs its duties specified under section 24 (I) of the Act and
 - (viii) The teachers shall not engage himself or herself for private teaching activities.
6. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

7. The school shall maintain in the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-



8. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
9. The school building or other structures or the grounds are used only for the purposes education and skill development.
10. The school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860). Or a public trust constituted under any law for the time being in force.
11. The School is not run for profit to any individual, group or association of individuals or any other persons.
12. The account should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the statement of Accounts should be sent to the District Education Officer every year.
13. The reorganization Code Number allotted to your school is EDN/GNL/A.P.S./2010/004. This may please be noted and quoted for any correspondence with this office.
14. The school furnish such report and information as may be required by the Director of Education/District Education Officer from time to time and complies with such instructions of the Appropriate Government/Local Authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the school.
15. Renewal of registration of Society if any is ensured.
