AFFIDAVIT

I, Rambilas Bidada, one of the Trustee of BJJ Memorial Educational Charitable Trust having its registered office at 17/5/1 and 521/1, Village Rakholi / Saily, Silvassa - 396 230, Union Territory of Dadra & Nagar Haveli do hereby state and affirm, confirm and declare, for on behalf of board of trustees of the Trust, as under:

1. The BJJ Memorial Educational Charitable Trust has been formed vide Declaration of Trust on 3rd June, 2009 with Shri K H Gopal as the Settlor and the said document is registered with the Sub-Registrar of Assurances, Silvassa, Union Territory of Dadra & Nagar Haveli, under serial no. 2249/09 on 25th August, 2009.



2. The Board of Trustees is constituted with the following persons as the first Trustees of the said BJJ Memorial Educational Charitable Trust:

3. The Trust has been formed for the objects mentioned in clause no. 5 and the objects mentioned in the said Declaration of Trust dated 3rd June, 2009, which are more particularly as under:

EDUCATIONAL : To establish, support, upgrade, maintain, run and / grant aid to schools, colleges, Technical and Medical institutes, Educational training institutes, Physical educational institutes, Law colleges, Universities, Libraries, Reading Rooms, Hostel, Boarding houses, Laboratories, Schools in Hindi and English medium and other institutions and also generally for the development and or the advancement and diffusion of knowledge among the public in general, The Trust may also assist in granting individual scholarships for poor, deserving and needy students.

MEDICAL : To establish, run , maintain or assist any medical institution for providing medical treatment to needy and indigent persons.

WELFARE : To conserve and conduct, disclosure, conversations, seminar, institute and centres of learning etc. for harmonious development.

OTHERS : To undertake any other activity incidental to the above activities but which are not inconsistent with the above objects.

If any of the above described object/s is found to be inconsistent with the objects of the public charitable institution under section 11 or under any other sections of the Income Tax Act, 1961 or any other direct tax law or any other law applicable to such trusts as now enacted or as may be enacted or amended at a future date, the objects stated above paragraphs will be treated as so modified to accord with such law or amended law so that any concessions, privileges, conditions or regulations available to and applicable to such public charitable institutions shall be available or applicable to this trust as well so that this trust will continue to retain its



character as public charitable institution without profit motive with public character within the meaning of all such laws.

4. The Trustees will not be entitled to any remuneration save and except right to receive reimbursement of the expenses incurred to discharge their duties. Neither the Settler, the Trustees nor their families, nor any members of their families nor any relatives or concerns in which any of these persons are interested will be entitled to any benefit prohibited by section 13 of the Income Tax Act, 1961 or otherwise directly or indirectly from the trust.
5. The Trust is irrevocable and will continue in perpetuity. It will continue to retain its character as a public charitable institution without profit motive with public character within the meaning of all such laws and will be in the nature of non-proprietary concern. All the objects of the Trust and its activities will be confined to India and will be carried out without profit motive and without any distinction on account of caste, creed color or religion.
6. This declaration of mine is true and no portion thereof is false and I have not concealed anything material or relevant to the matter herein mentioned.
